the IP address from which the user connects
the domain name of the device used
parameters related to the device used (operating system, browser used)
the URL addresses of the pages visited by the user
the parameters, methods and results of the requests used to access the resources visited

This data is necessary for the operation of the myIng.it application and is processed to:

- Verify the correct functioning of the services
- Support in case of malfunctions or requests for assistance sent by users
- Obtain statistical information on the use of services

RIGHT TO COMPLAIN

Whenever a data subject considers that the processing of his personal data violates the provisions of the GDPR, the subject may file a complaint to the Personal Data Protection Authority (www.garanteprivacy.it), or to the Guarantor Authority of the country of his habitual residence, country of employment or, finally, the place of alleged infringement. In alternative, the interested party can file a complaint in the appropriate courts (art. 79 of the Regulation).
